Notes	The second Spanish National Conference on Rare Diseases, organised by the Spanish National Alliance FEDER, took place in Madrid on 20 and 21 November 2014. Participants to the conference were structured into 10 working groups (WG): Group 1: Governance and monitoring of the National Plan; Group 2: Definition, coding and recording of RD; Group 3: Information and training on RD; Group 4: Research; Group 5: Centres, Services and Units of Reference; Group 6: Healthcare Model; Group 7: Orphan drugs and health products; Group 8: Social Services, helpline, disability; Group 9: Work inclusion; Group 10: Educational Inclusion. The WGs altogether involved more than 140 stakeholders, representing the main sectors linked to rare diseases. The aim of this conference was to collect the proposals and recommendations of the working groups on each of the above issues related to rare diseases and present them to the competent bodies for possible adoption and implementation.
